Re: Rail Infrastructure Projects, 49 C.F.R. § 1250.4

Dear Mr. Higgins:

This letter describes significant rail infrastructure projects by the Grand Trunk Corporation, on behalf of the U.S. rail operating subsidiaries of Canadian National Railway Company (collectively CN), that will be commenced in 2023. Pursuant to 49 C.F.R. § 1250.4, a "significant rail infrastructure project" has anticipated expenditures in excess of \$75 million USD.

At this point, CN does not anticipate it will commence in 2023 any new significant rail infrastructure project with an anticipated expenditure in excess of \$75 million.

CN has submitted a Responsive Application in the CP-KCS merger asking the Board to impose a condition to divest the KCS Springfield Line to CN. That KCS line runs between Kansas City, Missouri and Springfield, Illinois. As part of its divestiture proposal, CN has committed to investing at least \$250 million in the Springfield Line and in CN's adjacent Gilman subdivision. Those projects are not expected to begin until year 1 after any Board approval of the CP-KCS merger.

Below is the table showing the transaction-related rail line construction that CN has submitted to the Board's Office of Environmental Analysis in CN's submission on February 22, 2022.
