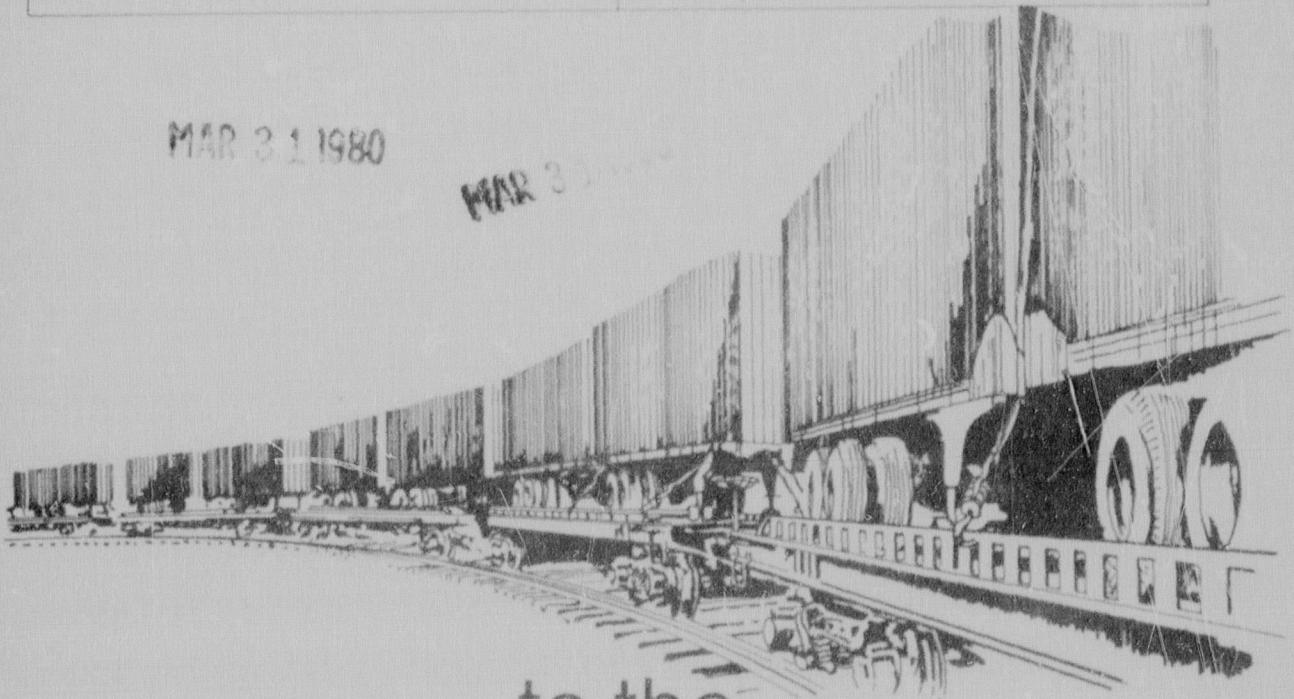

7. 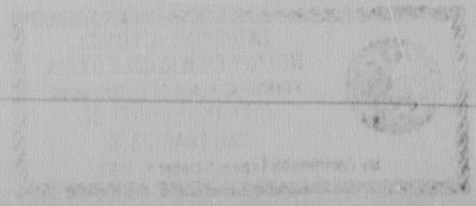

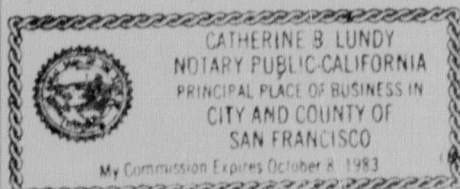

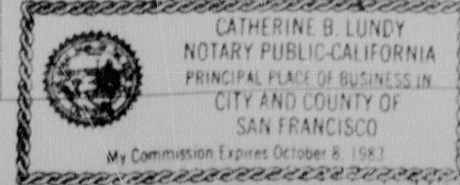
