# 1. SIT Yard and Yard Expansion

### **Description and Purpose:**

Construct a new storage-in-transit (SIT) yard at Angleton, TX along with an accompanying classification yard expansion to the existing yard. The primary purpose of the overall project is to increase Union Pacific's capacity to handle increasing plastics traffic and SIT infrastructure demands.

### 2. Port Laredo

### **Description and Purpose:**

Terminal expansion and modernization project to provide increased capacity and higher productivity as well as increased safety at the intermodal ramp.

# 3. LATC

#### **Description and Purpose:**

# 4. G4 Intermodal facility

# 5. Geneva 3<sup>rd</sup> Main Track

### **Description and Purpose:**

Construct 8 miles of new third main line track which will create a 41 mile stretch of triple main line track on Union Pacific's Geneva Subdivision, which runs from Chicago to Clinton, Iowa. The project will enhance fluidity, improve premium service, and improve passenger on-time performance on the corridor.

# 6. Brazos Classification Yard
