Public & Media Advisory: Surface Transportation Board Provides Schedule of Appearances, Time Allocations & Instructions for Public & Media Attendance at Sept. 10 Oral Argument in "Duke Energy v. CSX" Rail Rate-Complaint Case

Surface Transportation Board (Board) Chairman Roger Nober today provided a schedule of speakers' appearances, and instructions for public and media attendance, at the Board's **September 10, 2003** public hearing concerning the railroad rate-complaint case entitled *Duke Energy Corporation v. CSX Transportation, Inc.*, STB Docket No. 42070.

The Board will hold the September 10 oral argument beginning at 10:00 a.m. EDT in the Board's hearing room on the 7th Floor of the Mercury Building, 1925 K Street, N.W. (on the northeast corner of the intersection of 20th & K Sts.), Washington, D.C.

MATTER AT ISSUE:

The Board is holding the September 10 oral argument to allow the two parties in this rate-complaint proceeding, the Duke Energy Corporation ("Duke") and CSX Transportation, Inc. ("CSX"), to present their positions in a public forum. At issue is Duke's complaint challenging the reasonableness of the rates charged by CSX for movements of coal from various mine origins in Virginia, West Virginia, and Kentucky to Duke's electricity-generating plants located in North Carolina and South Carolina. Duke has asked the Board to prescribe the maximum reasonable rates that CSX may charge for this traffic.

INSTRUCTIONS FOR PUBLIC AND MEDIA ATTENDANCE:

- There will be no reserved seating. Given the following procedures, please plan to arrive early enough to be seated no later than 9:45 a.m.
- Please enter the Mercury Building's main entrance at 1925 K Street (on the northeast corner of the intersection of 20th and K Sts.).
